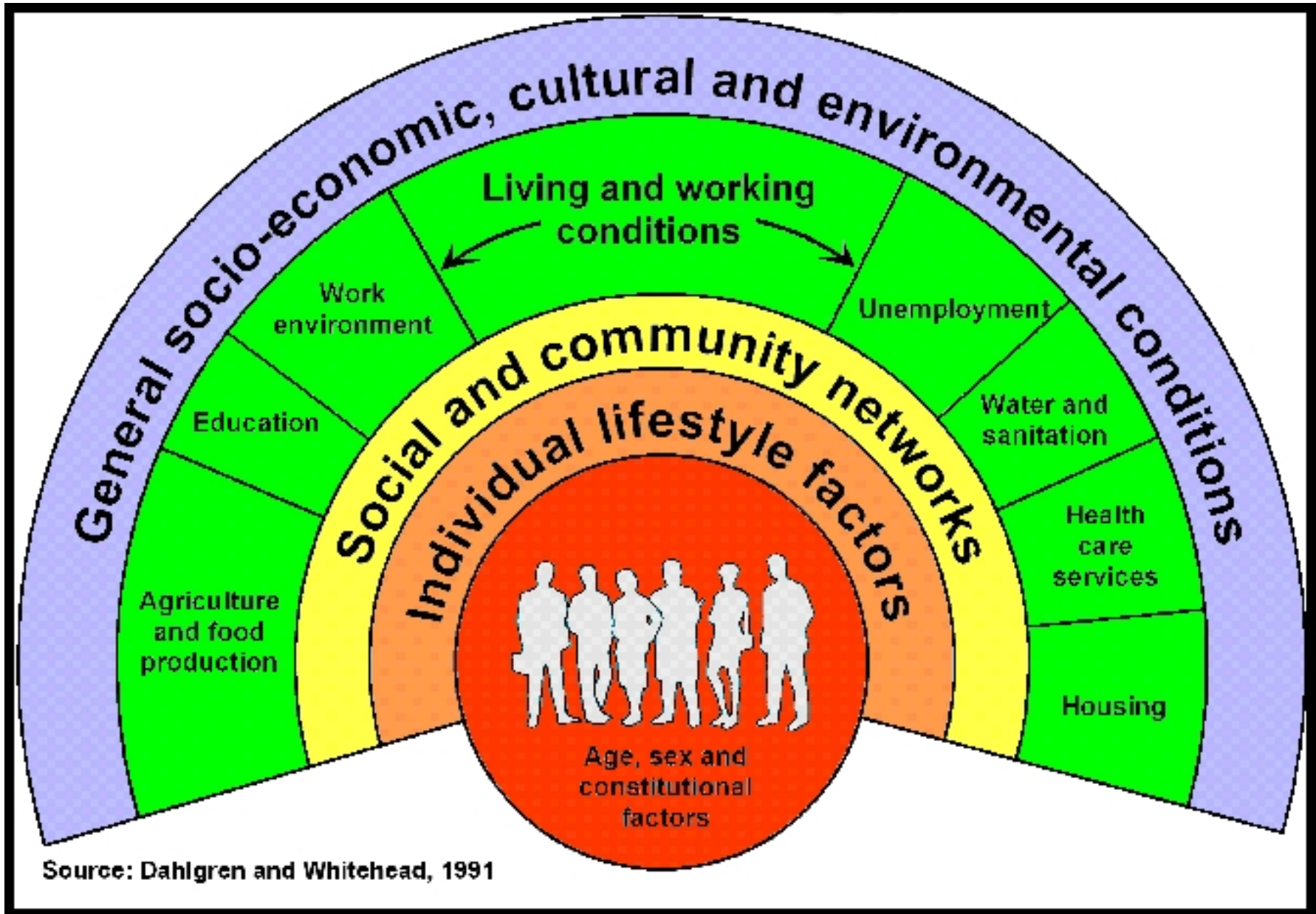

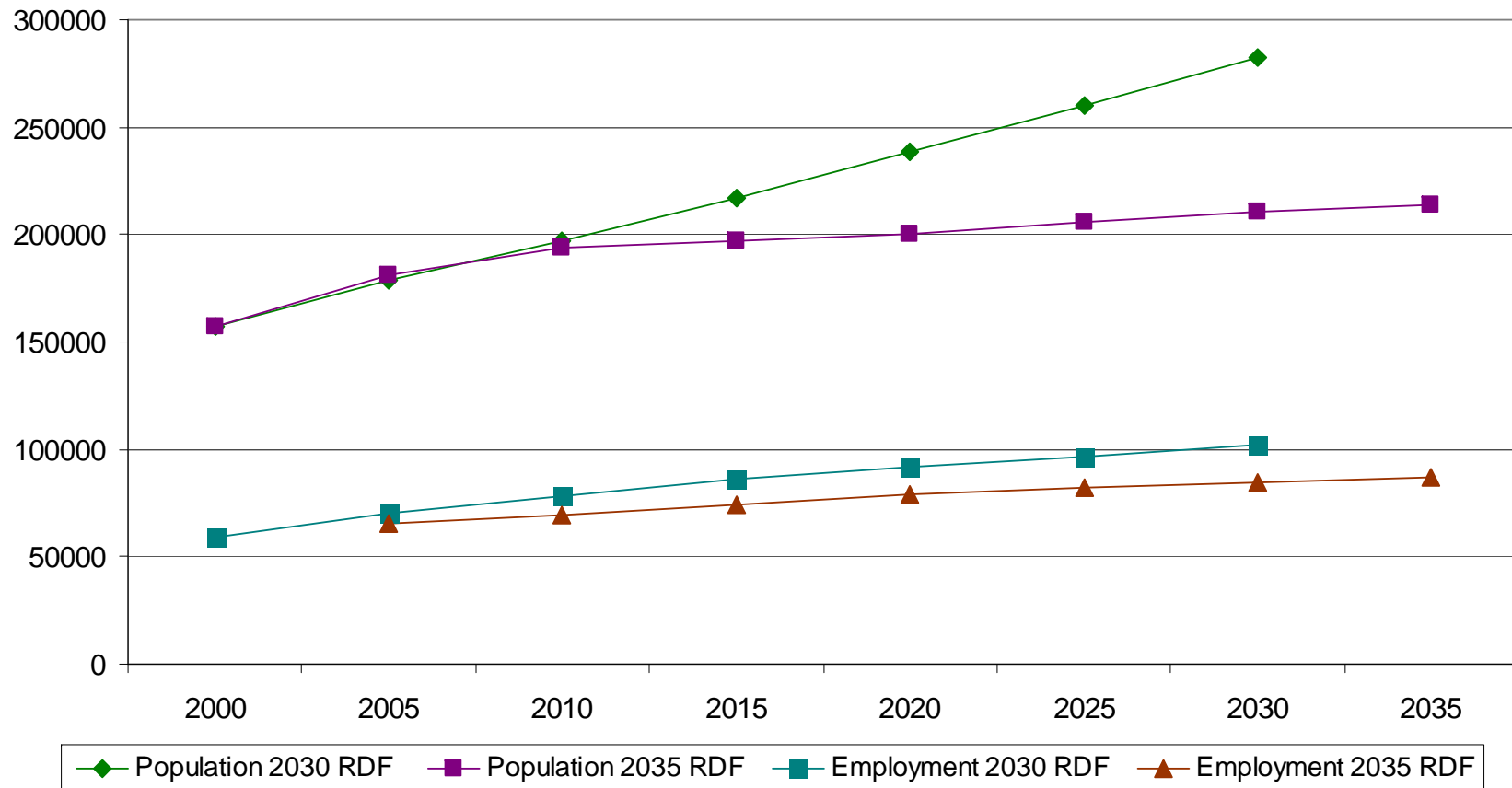


Population - 2000 to 2035

- Population growth has slowed.
- Birth rate declining, total births will peak by 2020.
- Total population growth now expected to reach 210,000-213,000 by 2035.

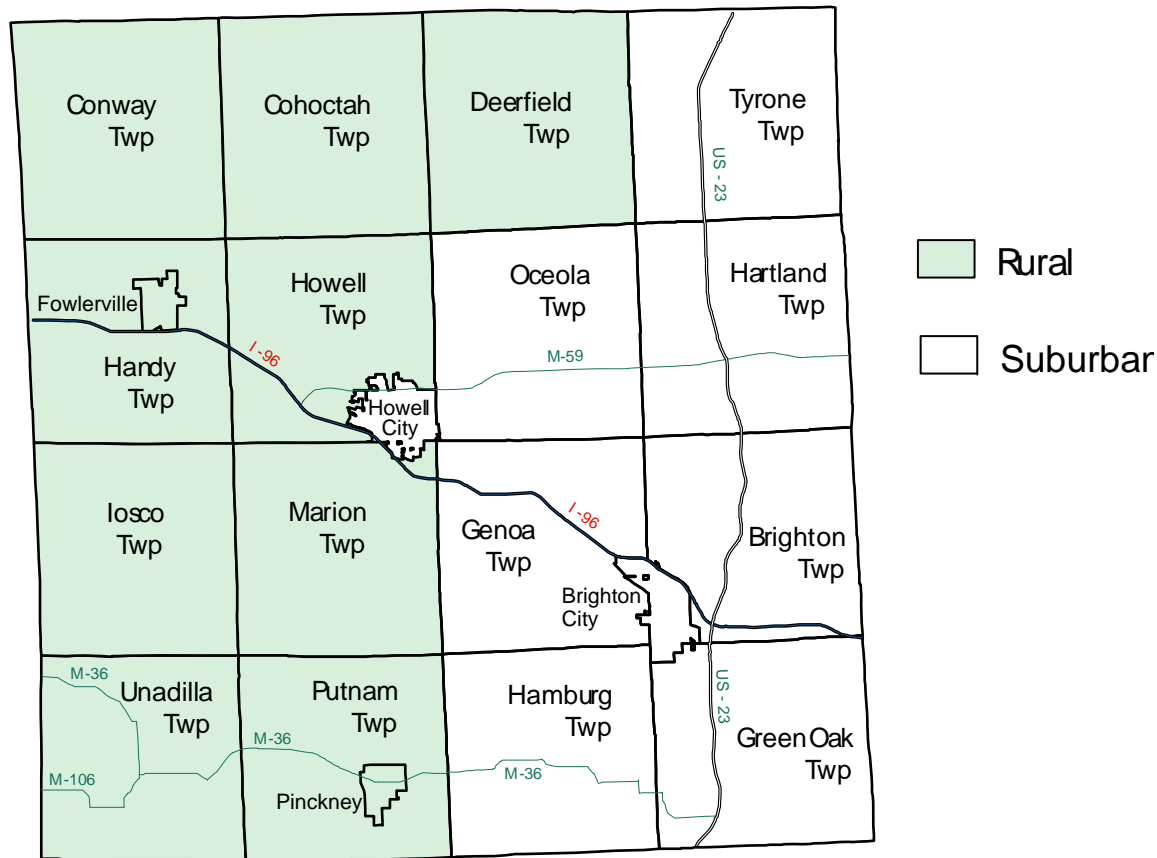


Community Survey – Livingston County


- ✓ Health Related Behavior Risk Factor Survey
- ✓ CDC instrument and protocols with several locally developed questions
- ✓ 773 randomly selected households; 135 State sponsored and 638 County sponsored (70% suburban and 30% rural)
- ✓ Respondents stratified by:

Gender	Marital status
Age	Children <18 in home
Education	Household income

Community Survey

- Overall, Livingston metrics compare more favorably than the State as a whole.
- The highest risk populations are those with lowest levels of education and income.
- Reported alcohol use is higher than the state and nation, as well as had been drinking crashes.

- Substance Abuse

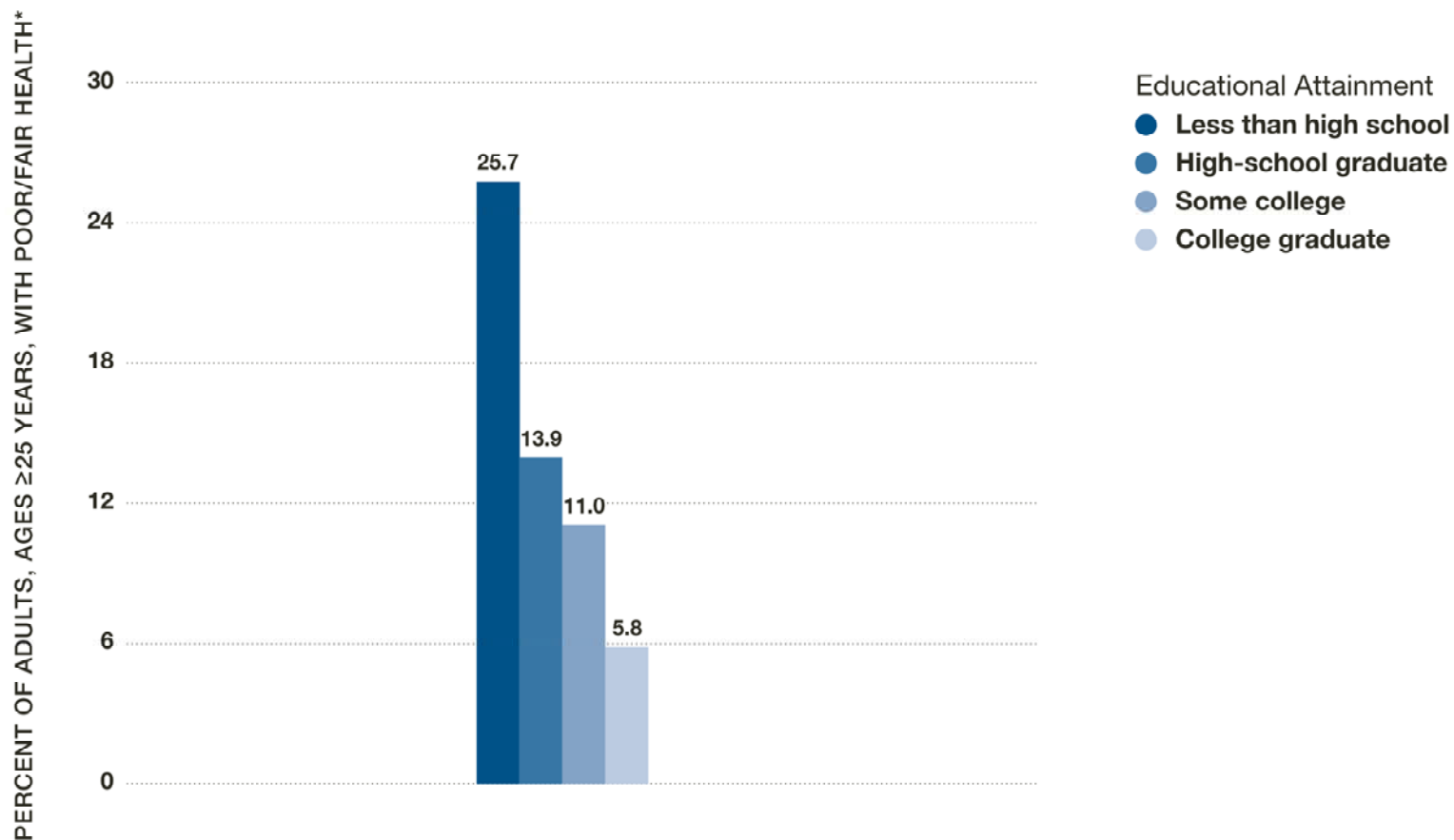


Education

- Education and the associated income are a leading determinant of health.
- RWJ-Commission Health focused on the importance of education.
- Livingston educational attainment compares favorably to the state and nation.

Less Education, Worse Health

Less education is linked with worse health. Compared with college graduates, adults who have not finished high school are more than four times as likely to be in poor or fair health.

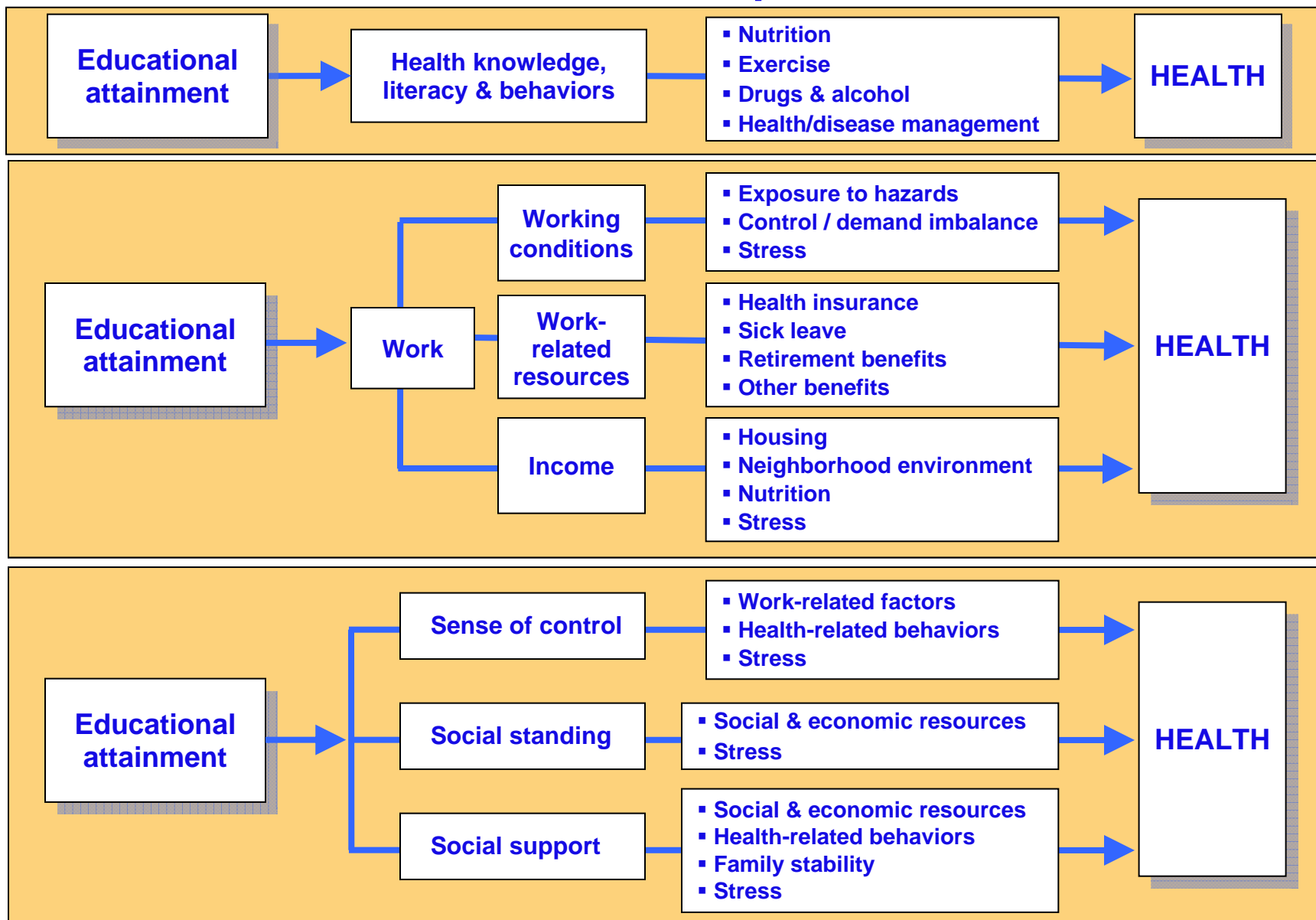

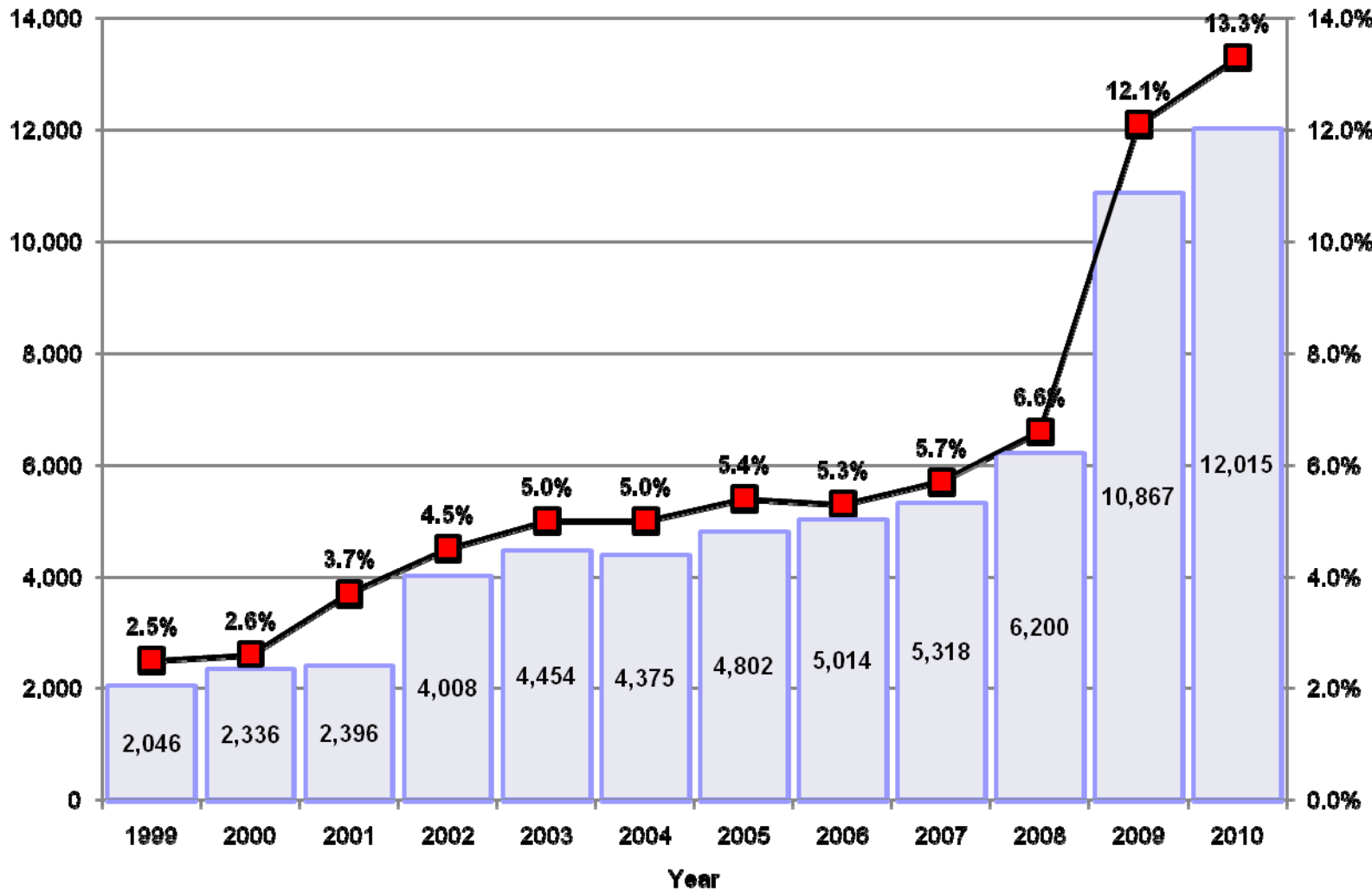
Unemployment: Livingston in 2009: 12.1%
1st Quarter 2010: 13.3%

Significant job loss last decade 7,829 jobs, overall down 15.5%.

- Manufacturing 43.8% (62% of total loss)
- Construction 54.4% (33% of total loss)
- Insurance/Finance 28.2%

- Residential building net units at nearly a 40 year low.

Poverty

- Increased significantly in 8 years from 2000-2008.
- Census estimates indicate that persons below poverty (<100% FPL) more than doubled.
- Persons at or near poverty (<200%FPL) doubled, increasing to 32,000 persons, or nearly 18% of total population.
- Free and reduced price lunches for school children nearly tripled in the last decade.

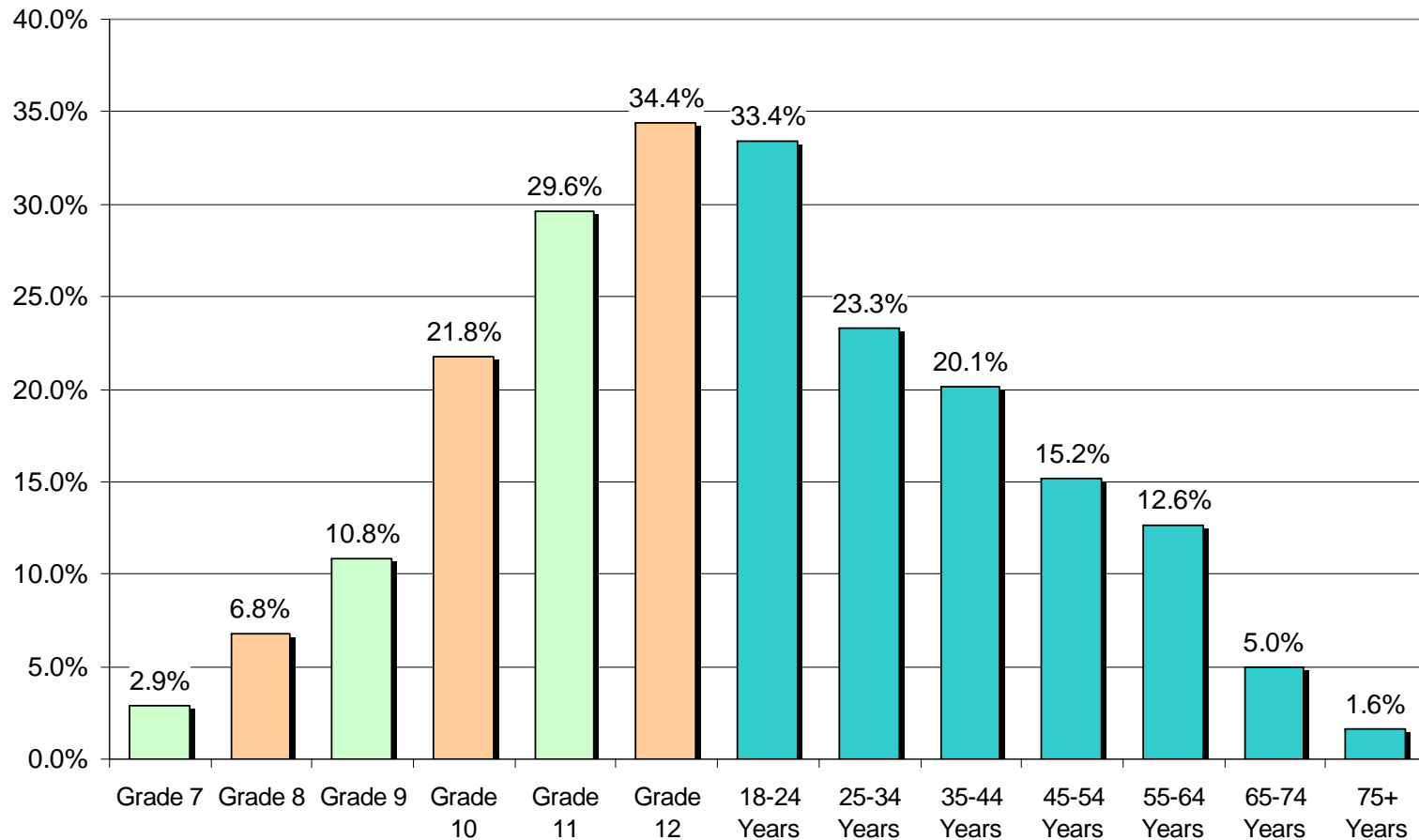
